**APPROVING A SMALL BUSINESS FINANCIAL ASSISTANCE GRANT TO BLAZIN' J'S, LLC TO
ACQUIRE AND INSTALL KITCHEN EQUIPMENT FOR A NEW RESTAURANT TO BE LOCATED AT
15 EAST KING STREET, LANCASTER**

WHEREAS, on February 26, 2019 the City of Lancaster Revitalization and Improvement Zone (CRIZ) Authority approved allocating \$250,000.00 of available Series 2015 Tax Revenue Bond proceeds to create a CRIZ Small Business Financial Assistance Grant Program that will provide grants up to \$25,000.00 to small businesses located in, or locating in, the existing CRIZ District; and

WHEREAS, the Project Review Committee met on August 13, 2019 to review an application from Blazin' J's, LLC to obtain assistance to cover the cost of acquiring a refrigerator and deep fryer and installing a code-required range hood for their new restaurant to be located at 15 East King Street; and

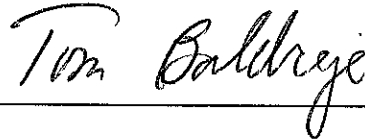
WHEREAS, the Project Review Committee has recommended approval of the Blazin' J's, LLC's application for a \$20,000.00 CRIZ Small Business Financial Assistance Grant.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the City of Lancaster Revitalization and Improvement Zone (CRIZ) Authority to approve a \$20,000.00 Small Business Financial Assistance Grant to Blazin' J's, LLC to cover the cost of acquiring a refrigerator and deep fryer and installing a code-required range hood for their new restaurant to be located at 15 East King Street, Lancaster, PA.

BE IT FURTHER RESOLVED that the Acting Executive Director is hereby authorized to prepare all legal documents, with the assistance of legal counsel, required to provide the CRIZ financial assistance as hereby approved by the CRIZ Authority.
